TYPES OF PUBLIC PROJECTS

Contractors holding either: Class A licenses and the equipment and expertise to self-perform the following types of work; Class B licenses (which require hiring two unrelated building trades or crafts to perform the work); or Class C licenses pertaining to the following types of work are invited to register to be notified of informal bidding opportunities with the Carmel Area Wastewater District per the CUPCCAA guidelines.

	FOR ALL OTHER WORK: Combined Single Limit, Bodily Injury and Property Damage Per Occurrence: One Million Dollars (\$1,000,000). Aggregate: Two Million Dollars (\$2,000,000)
Auto Liability for owned, non-owned and hired vehicles	FOR SEWER MAIN WORK: Two Million Dollars (\$2,000,000) for bodily injury and property damage each accident limit. Aggregate: Four Million Dollars (\$4,000,000)
	FOR ALL OTHER WORK: One Million Dollars (\$1,000,000) for bodily injury and property damage each accident limit. Aggregate: Two Million Dollars (\$2,000,000)
Workers' Compensation	One Million Dollars (\$1,000,000), per claim in accordance with the laws of the State of California
